1. **Setup / Breakdown:** All Vendors must be set up and ready to sell by 8:50am the day of the Garage Sale / Arts & Crafts Fair. Vendors may begin setting up at 8:00am the same day. Breakdown is between 2:45pm and 3:30pm. Sellers are responsible for their selling spaces. *Before leaving, be sure your area is clean and trash-free.
2. **Staffing:** Vendor booths must be manned at all times and intact until show closes. Princeton Health & Fitness is not responsible for merchandise or display materials.
3. **Vendor Responsibility:** Vendor will be fully responsible for any loss or damage to their property by theft, fire or casualty. Each vendor is responsible for the conduct of employees and/or representatives.
4. **Exhibitor Spaces:** Exhibitor spaces will be assigned. If you have special space needs, please include your request with your application and we will make every effort to accommodate you. Spaces are reserved on a first-come, first-served basis.
5. **Payment:** The full payment is a non-refundable registration fee for the selected space and is due with the submission of this agreement. This fee will be used to cover advertising and other incidental costs associated with the production of this event.
6. **Electricity:** Electricity will be available on a first-come, first-served basis as electricity is not available at all areas. Electrical service requires an additional fee. Outlets are NOT guaranteed. Extension cords are not included in the fee and must be provided by the Vendor.
7. **Tables & Chairs:** Each Vendor may furnish their own tables, chairs, stands, or canopy. If you wish to rent tables, please note that on application. Chairs are provided free of charge.
8. **Indemnification:** Vendor agrees to indemnify and hold harmless Princeton Health & Fitness from and against any loss, expense, claims, damages, causes of action, injuries, suits or damages, suits to person or property, including attorney's fees, arising out of or related to the operation of the Vendors at the Princeton Health & Fitness Garage Sale / Arts & Crafts Fair.
